

What is Website Accessibility?

"Web accessibility means that websites, tools, and technologies are designed and developed so that people with disabilities can use them." - W3C





Which Websites are Required to Be Accessible?

FACT; Businesses or organizations that contract with federal agencies or receive federal funding must meet an even higher level of compliance by law.



How Do I Make My Site is Accessible?

Sites need to be coded and designed according to official guidelines so that they're accessible to all—with stiff legal penalties for those who don't comply.

Website Content Accessibility Guidelines (WCAG) 2.1 are the standards a site must follow. They are technical and require a certified technician to implement.


